#### X. COMMITTEE REPORTS:

# 1. Administrator's Report.

We received the jail bids last week. With those bids we are about 5 percent over budget for the project which is not a cost overrun because we aren't locked into the costs yet. The Construction Manager and Architect are working on value engineering proposals to reduce the cost of some of the contracts. I hope to have more information next week. I'll present an overall update on the project, including some of the winning bidders.

The Planning Commission discussed the process for considering 40 conditional uses for wind turbines last night. Conditional Use decisions do not reach the County Board. The meeting dates for the public hearings will be 5-8 pm on December  $4^{\rm th}$  and December  $12^{\rm th}$ . There will be a public hearing for each of the 40 permits.

Prosecutor Strom and I have been in contact with a law firm in Traverse City that is suing pharmaceutical companies on behalf of counties. The Sheriff, Prosecutor and I will meet with them and we'll have more information next week.

Had a meeting with CUPPAD this morning to talk about our GIS platform. Flyover data that was done in the spring will be available to township supervisors and assessors starting tomorrow. They are much better quality and will be put on the County GIS website. Thank you to the Treasurer for purchasing the information.

Drug Court was only approved for \$35,000 out of the \$45,000 requested from Northcare. We're disappointed in that. Delta County has \$185,000 in PA2 dollars, and Drug Court is a great use of them.

# 3. Indigent Defense Standards.

Emily DeSalvo, District Court Administrator, gave a presentation to the Board regarding the Indigent Defense Standards. The courts are required to have an Indigent Defense Plan. The Board will need to approve the policies for the preliminary plan when it is completed.

# 4. GPS Monitoring - Budget Amendment.
