## Personal Property Tax Phase Out Reimbursement Check

Manufacturing personal property tax was phased out last year, costing us \$414K, the State planned to reimburse us for the loss with a "Use Tax" on manufacturing. The Use Tax was much higher than anticipated, personal property tax losses were less. Lost \$414,000 but received \$1.1 million, which will lead to a large surplus. After the Pension Stabilization Fund is maxed out at 15%, I will recommend an additional payment to our actual pension fund, which is only funded at 72%.

# Received paperwork on how to extend amortization for pension system.

Can pair one-time lump sum payment with amortization extension. The goal is to stabilize the out-years.

# Energy Project

Building and Grounds meeting tomorrow on project updates. The work going on near the jail is NOT for the jail. That is the maintenance room that leads into the Courthouse.

# Showed the detached Michigan Works building to additional State Police personnel.

Met with Lt Cunningham and the Lt. from the Negaunee post. Will continue to communicate with State Real Estate Budget office. Opportunities may be there to put money into the project to secure a long-term lease.

# 1. Non-Union 2% Salary Increase.

### 2. Building and Zoning Departmental Director Supplement.

Moved by Commissioner Moyle and seconded by Commissioner Malnar to add a \$3,600 supplement (no MERS) to the B&Z Director's salary for taking on the City of Gladstone's inspections with the supplement only being effective while the county maintains a cooperative agreement with Menominee County. The supplement will not roll up into MERS. MOTION CARRIED.
