Judge Economopoulos met with the Administrator, the Maintenance Director and Commissioner Tatrow regarding a security window for Circuit Court. It will be priced out and brought to you at the next meeting.

Fuller Park property 16 acres was appraised at approximately \$23,000. May be able to sell the southernmost piece across the highway but leave everything at or north of the well. Will bring this for consideration to one of the next two meetings.

The City of Escanaba has a prepared contract to pay us \$24,000 a year for Equalization Services. We would turn around and sign an amendment with our Equalization Director—who would get \$18,000 of it. This will be on the agenda at the next meeting.

The Auditors are currently working. Everything ok so far. We know our large surplus (due to the Personal Property reimbursement from the State) will max out the Pension Stabilization Fund. We may want to add second policy to commit surplus above Pension Stabilization Amount to be immediately paid to our actual \$10 million unfunded liability.

Approximately \$45,000 in old Hannahville Funds available - preferably to update address signs in the County. This has already been cleared with Hannahville. 2% grants are due at the end of March.
