IX. COMMITTEE REPORTS:

1. Administrator's Report.

We awarded 10 contracts from bid package 1, totaling \$7.36 million. 5 went to Delta County companies. 2 more went to Miron who uses local labor. There were 3 contracts that UP companies did not bid on, including specialized detention and security equipment. They will likely start in early September. We had a meeting with our Construction Manager and Architect on August $8^{\rm th}$. We seem to be on budget going into the second bid package, which will be released in September for the Heating, AC, Electrical, Plumbing, General Trades.

97 inmates in the jail yesterday — called in overtime and will consider overcrowding procedures such as early release.

The timber cut is wrapping up on the Service Center. Ended up taking more trees than anticipated because of wind and esthetic concerns. Has been successful however and we will get paid within a few weeks.

On the Washington DC NACO trip, our Commissioners were able to make a contact with a special assistant to the President That contact has worked on behalf of our USDA loan. It had been past the local stage, now its past the state stage, and submitted to the federal office.

Judge Economopoulos had requested a rep from SCAO to come up and review Court Security which happened on August $8^{\rm th}$. We should get a report in a few weeks.
