 - 1. Administrator's Report.

There are new ADA rules on government websites. There are no exceptions. It is going to take significant time investment to put all agenda materials on the website.

We had a owners construction meeting this morning on the jail facility. We've used only 5% of our construction contingency, and we're probably about 40% through the project. We also may have an earlier completion date than the initial November 19th date. We are currently on schedule and on budget.

Sent the transition team up to Marquette to review their mental health diversion model.

All reimbursement has been approved for our DNR Trust Fund Grant.

The Planning Commission approved the special use permits for 36 wind turbines at the meeting yesterday. No board action is required. If there is an appeal, by rule it would go directly to Circuit Court.

2. Judge Parks: District Court Updates.

Judge Parks gave the Board an update on the District Court. District Court had taken over sentenced Community Service Program when the Community Corrections lost funding. John Harris is doing a good job. Community Service is a great tool. 362 people with a 93% completion rate and a total of 11,700 hours. They are building benches and kid's tables. Proceeds will be given back to the community. Drug Court started about 1 ½ years, in 3-4 months will have first four graduates - who were high risk IV drug users. Judge Parks has been with the county for 14 years and stated Administrator Ryan Bergman has brought transparency and integrity to the county.

3. 2017 Foreclosure Report.

Treasurer Tom Sabor gave the Board the 2017 Foreclosure Report for the 2014 taxes. Started March 1 with 326 delinquent tax properties. Last August, auctioned 21 properties which included 14 abandoned homes and 7 vacant lots. 19 properties were sold at auction which left one empty lot and one abandoned home, which will be torn down and the empty lot sold. Moved by Commissioner Moyle and seconded by Commissioner Tatrow to receive the 2017 Foreclosure Report and place on file. MOTION CARRIED.

4. Menards Tax Tribunal Cost Sharing.

Moved by Commissioner Moyle and seconded by Commissioner Tatrow to pay the City of Escanaba \$21,020.68 for attorney fees for the Menards Tax Tribunal lawsuit based on the 2017 apportionment not to include 911 and the Landfill portion,

with future reimbursements for only the Menards Dark Store case. MOTION CARRIED.

5. Airport Manager Search Update.

There were 38 candidates who applied for the Airport Manager position, eight candidates were interviewed with three candidates being selected as finalists. They will be interviewed February 19 and 20th.

6. Jail Management Software Bid Opening.

The bids for the Jail Management Software RFP were opened. The bids were given to the Sheriff to review with the IT Director and make a recommendation.

7. Child Advocacy Center Lease Agreement.

Moved by Commissioner Moyle and seconded by Commissioner Johnson to approve the Child Advocacy Lease Agreement for \$1,150 per month including utilities, based on the Memorandum of Understanding, as presented. MOTION CARRIED.

8. Letter of Support - Non-motorized Pathway System.

Moved by Commissioner Johnson and seconded by Commissioner Moyle to authorize a letter of support for the City of Escanaba Trust Fund Grant request to connect the north side of Escanaba to the non-motorized pathway system. MOTION CARRIED.

9. Rapid River Trust Fund Development Grant.

Rory Mattson, DCCD Director, gave the Board an update on the Rapid River Falls Trust Fund Development Grant application for campground facilities. A second Public Hearing will be held at 6:00 pm on February 13 at the USDA Service Center in Gladstone. CUPPAD will be doing the mapping for the project. The Board will need to approve the final resolution and the matching funds for the application.

10. Michigan Salt Bill.

Moved by Commissioner Johnson and seconded by Commissioner Moyle to authorize a letter opposing Senate Bill 363 which creates a preference for the salt produced in Detroit. Will cause problems for our Road Commission who will have to pay a higher price. Additionally, our salt currently comes in through the Gladstone Port, which is good for the port. MOTION CARRIED. XII.
