4. Pinecrest Medical Care Facility - Executive Director.

Darlene Smith, current Administrator of Pinecrest Medical Care Facility, introduced the new incoming Administrator, Nicole Freeland. She then spoke about pursuing a millage in the three counties Pinecrest serves, including Delta County. The combination of an aging building, ongoing training requirements and revenue collection issues have left them dipping into their

investments to cover their expenditures. In Delta County they would be seeking 0.45 mils and would like support of the millage from Delta County.

Additionally, to complete a walking path in Spalding Township, a one acre plot of land would need to be deeded from Pinecrest to Spalding Township. Moved by Commissioner Johnson and seconded by Commissioner Moyle to allow Pinecrest to deed a one acre plot of land for the walking path with a right of way access easement to a wooded area for the purpose of a timber cut. MOTION CARRIED.

5. MNRTF Grant Application and Resolution - ORV/ATV Campground at Rapid River Falls Park.

Moved by Commissioner Johnson and seconded by Commissioner Nelson to approve the grant application and resolution for the ORV/ATV campground with the county covering the 25% local share of the grant, as presented.

6. Mid Year Financial Report.

Administrator Bergman presented the 2018 mid-year financial report which included a look at the Fiscal year 2017 audit, review of the current budget projections, and preliminary planning for the FY 2018 budget. The report indicated that the financial state of the County is very strong due to high fund balances, recent taxable growth, low amount of debt, and a maxed out pension stabilization fund.

7. Forest Service Building Authorization.

US Forest Service would like to build a building on some property owned by Delta County in Rapid River. They currently have an old building. Moved by Commissioner Johnson and seconded by Commissioner Moyle to approve the new building with the condition that they house our 911 equipment in the new building. MOTION CARRIED.

8. Hannahville 2% Grants.

The process for applying for Hannahville 2% grants is now electronic. For ease of use, we will maintain one approval login for Administration. Any commissioner needing any grant supported would just need to notify the Administrator.

9. Road Commission Executive Director.

Jody Norman, Road Commission Executive Director, informed the board about an upcoming US Forest Service project to cut and haul and estimated 35.1 million board feet of timber from property off County Road 440, County Road 442 and Highway 13. His concern is the damage that will occur to those roads and is requesting that funds deposited into the General Fund from the Forest Service, be redirected to the Road Commission to upgrade those roads.
