1. Administrator's Report.

The steel cells from the Corrections Project are all delivered. Most are in place.

The trailer for the work behind the courthouse is in place and the parking lot is fenced off. They just need to wait for the frost to be out of the ground - approximately May 1st.

103 people in the current jail today. The Proposed Budget will include funding for 3 more full-time positions in the new Correctional Facility. We may want to use whatever funds we can to get these individuals hired early. Depending on part-time Officers at this overcrowding level is not ideal.

Probate Court is the next contract up and they've requested they be able to begin negotiations in the next couple of weeks.

I plan to include in my proposed budget at the April 17th meeting recommended guidelines for securing long term collective bargaining agreements with some of the other units.

I've sent a formal request to MERS to record the actuarial impact of a \$1 million payment to the pension system and how it would reduce our annual contributions over the next 10

years. I'm not sure if it will be back in time for me or my successor to act on it.

Our newly required retirement report has been prepared and sent to the state. We're a little under 70% funding based on these projections which are done by our auditors' calculations. We do not face any state corrective action.
