  - a. FY 2020 Revenue Report.

Campground revenues are down \$60,000 this year.

b. Theft Delta County Parks.

There has been a large pile of wood stolen from the Community Forest in Cornell this past week.

c. Delta County Parks Cabins.

\$100,000 has been donated to purchase 10 cabins - four for Pioneer Trail Park and six for Fuller Park.

d. PTP Sewer Project.

The total cost of the sewer project at Pioneer Trail Park was \$42,183.44.
