Chairman Aschbacher called the meeting to order at 4:30 p.m., followed by the Pledge of Allegiance.

Chairman Aschbacher moved to approve the minutes of the July 27, 2021 Regular Meeting.

Manager Jody Norman gave a brief administrative update:

There will be a budget update next meeting Tuesday, August 24 2021 as projects are wrapping up. Regarding the State System, things have been quiet, just mowing at this time. As hauling slows down at District 2, Jody will have the D2 crew do some state related items. BB Rd & the Village of Garden projects have been completed. Due to availability of a crane, the H-1 Bridge project has been postponed to September 30th. Verso has started their project on CR 470, they are open trenching rather than directional boring. The length of Verso's project may cause the Road Commission to have to postpone the proposed improvements on the road. Broadband is being installed throughout Delta County and right-of-way permitting has been underway. Jody has noted damage to county roads at fiber install locations. A meeting was held to discuss the importance to protect county roads and better install fiber along the roadway between Manager Jody Norman and Fiber Representatives.

It was moved by Commissioner Stempki, seconded by Commissioner Stanek to approve Bills Payable Voucher No. 2579 in the amount of \$222,899.71 and Payroll Voucher No. 69137 in the amount of \$81,789.87 as presented and reviewed.
