Alterations and repair work determined by the mechanical official to be of a minor nature. 3. Business, mercantile, and storage building have HVAC equipment only, with one fire area and not more than 3,500 square feet. 4. Work completed by a Government Subdivision or State Agency costing less than \$15,000.00.

All installations shall be in conformance with the Mechanical Code. No work shall be concealed until it has been inspected. When ready for an inspection, call the Inspector, providing as much advance notice as possible. The Inspector will need the job location and permit number.</p>	<p>EXPIRATION OF PERMIT: A permit remains valid as long as work is progressing and inspections are requested and conducted. A permit shall become invalid if the authorized work is not commenced within six months after issuance of the permit or if the authorized work is suspended or abandoned for a period of six months after the time of commencing the work. A PERMIT WILL BE CLOSED WHEN NO INSPECTIONS ARE REQUESTED AND OR CONDUCTED WITHIN SIX MONTHS (180 days) OF THE DATE OF ISSUANCE OR THE DATE OF A PREVIOUS INSPECTION. CLOSED PERMITS CANNOT BE REFUNDED OR REINSTATED.</p>
