**Plans are required** for all other building types and shall be prepared by or under the direct supervision of an architect or engineer licensed pursuant to Act 299 of the Public Acts of 1980, as amended, and shall bear the architect's or engineer's signature and seal.

<b>HOMEOWNER AFFIDAVIT</b>  <b>AND</b>  <b>APPLICANT SIGNATURE</b>	I hereby certify the plumbing work described on this permit application shall be <b>installed by myself in my own home</b> in which I am living or about to occupy. <b>All work shall be installed in accordance with the Plumbing Code and shall not be enclosed, covered up, or put into operation until it has been inspected and approved by the Plumbing Inspector.</b> I will cooperate with the Plumbing Inspector and assume the responsibility to arrange for necessary inspections.
	<b>Section 23a of the State Construction Code Act of 1972, 1972 PA 230. MCL 125.1523A</b> , as amended by 1999 PA 245, prohibits a person from conspiring to circumvent the licensing requirements of this State relating to persons who are to perform work on a residential building or a residential structure. Violators of Section 23a are subjected to civil fines.

RE-INSPECTION OF VIOLATIONS WILL BE ASSESSED ADDITIONAL INSPECTION FEES**

<p><b>GENERAL:</b> Plumbing work shall not be started until the application for permit has been filed with the Delta County Building &amp; Zoning Department. All installations shall be in conformance with the Plumbing Code. No work shall be concealed until it has been inspected. When ready for an inspection, call the Inspector, providing as much advance notice as possible. The Inspector will need the job location and permit number.</p>	<p><b>EXPIRATION OF PERMIT:</b> A permit remains valid as long as work is progressing and inspections are requested and conducted. A permit shall become invalid if the authorized work is not commenced within six months after issuance of the permit or if the authorized work is suspended or abandoned for a period of six months after the time of commencing the work. A PERMIT WILL BE CLOSED WHEN NO INSPECTIONS ARE REQUESTED AND OR CONDUCTED WITHIN SIX MONTHS (180 days) OF THE DATE OF ISSUANCE OR THE DATE OF A PREVIOUS INSPECTION. CLOSED PERMITS CANNOT BE REFUNDED OR REINSTATED.</p>
