

July 12, 2022

A Regular Meeting of the Board of Delta County Road Commissioners was held on Tuesday, July 12, 2022 at 3:30 p.m. at the Main Office, 3000 32<sup>nd</sup> Avenue North, Escanaba, Michigan.

Chairman Aschbacher called the meeting to order at 3:30 p.m., followed by the Pledge of Allegiance.

PRESENT: Chairman Bob Aschbacher, Vice-Chairman Randy Bjork, Commissioner Dustin Stempki, and Commissioner Mark Asselin.

ABSENT: Commissioner Dennis Stanek

Chairman Aschbacher moved to approve the Agenda as printed.

Chairman Aschbacher moved to approve the minutes of the June 28, 2022 Regular Meeting as proposed.

Manager Jody Norman gave a brief admin update:

Jody followed up on the recent Legislative Updates regarding the Michigan Transportation Fund & stated funds will not be benefiting the Road Commission. On the MDOT system things are at a stand still as the Road Commission has hit its allowed budget for now. Upcoming MDOT projects the Road Commission will be helping with in the future include 4 vaults in Iron Mountain and the Mill & Fill in Escanaba. On the County System, the crew is wrapping up seal coating. The seal coat on Hwy 13 should be finished up tomorrow, 7/13/22. At the District 1 Garage, the sweeper continues to have maintenance issues. At the District 2 Garage, the computer that runs their fuel system failed. A new one has been ordered & an upgrade will be needed. A possible solution is in the works to be able to control the fuel system from District 1 Garage. An agreement for the Skellenger Quarry in East Rock has been signed.

It was moved by Commissioner Asselin, seconded by Commissioner Stanek to approve Bills Payable Voucher No. 2601 in the amount of \$1,021,830.06 & Payroll Voucher No. 69161 in the amount of \$86,858.40.
