

A Regular Meeting of the Board of Delta County Road Commissioners was held on Tuesday, October 25, 2022, at 3:30 p.m. at the Main Office, 3000 32<sup>nd</sup> Avenue North, Escanaba, Michigan.

Vice-Chairman Bjork called the meeting to order at 3:30 p.m., followed by the Pledge of Allegiance.

Vice-Chairman Bjork moved to approve the agenda as printed.

Vice-Chairman Bjork moved to approve the minutes of the October 25, 2022, Regular Meeting as proposed.

Manager Jody Norman gave a brief admin update:

On the MDOT system the crew is doing as needed work & focusing on finishing up the last of the projects on the County System. Then the crew will be working on transitioning things to winter maintenance. Jody has been talking with Rory Mattson about a possible Water Shed Program for Bark River. Jody informed the Board that a temporary employee has been hired for the winter maintenance season. He also let the Board know the employees will have the option to participate in the Wellness Program again this year. Jody also informed the Board that Payne & Dolan was interested in purchasing approximately 3,000 tons of the Road Commission's 23A gravel for shouldering CR 430 & CR 432 next year.
