

Michigan Notary Public Application and Instructions

This application process for becoming a Michigan Notary Public involves several steps. Carefully review the instructions throughout this document to ensure successful and timely completion. Most questions may be answered by reviewing our <u>frequently asked questions</u>. For further assistance, email us at <u>MDOS-Notary@Michigan.gov</u>.

STEP-BY-STEP INSTRUCTIONS:

- 1. Fill out the application **clearly** and **completely**. Use "None" or "N/A" if not applicable.
- 2. Obtain a \$10,000 surety bond written for a term of six or seven years through a Michigan licensed insurance company. An attorney in good standing with the State Bar of Michigan is not required to obtain and file a surety bond; however, you must swear an oath with the county clerk's office.
- 3. Take the surety bond and completed application to the county clerk's office. (For a \$10.00-\$20.00 fee, the clerk will file your bond, administer an oath, and return the application to you.)
- 4. Submit the original, completed application and the \$10.00 filing fee to this office using one of the methods below:
 - a. <u>Submit the application</u> and pay by credit or debt card or e-check online. Allow 2 weeks processing time.
 - b. Mail the application and a check or money order payable to the State of Michigan to the address below. Allow 4-6 weeks processing time from the date your fee is received.

(Note: Out of state applicants must also include a copy of their Driver's License or State ID and a letter from their employer with <u>specific information</u>.)

- 5. Once your commission has been approved, your commission card and wall certificate will be available on your <u>MiLogin account.</u> You will also receive email notification from <u>Noreply-CARS@Michigan.gov</u>, with instructions on how to retrieve your commission card and wall certificate. Please check all spam folders.
- Check the status of your commission on our <u>website</u>. Bookmark this site to visit later. (Note: **Do not** perform notarial acts until you are listed as "Valid" on this website or you have received your commission information!)

Do not forget the \$10.00 filing fee payable to the State of Michigan if you mail your application. <u>Submit online</u> or mail the completed application and filing fee to:

I am submitting the \$10.00 non-refundable application processing fee online or by mail to the Office of the Great Seal, 7064 Crowner Dr., Lansing MI, 48918, with checks made payable to State of Michigan. **If I am a licensed attorney, I certify that I am in good standing with the State Bar of Michigan.**
