Three of you are facing a recall petition and your jobs are in jeopardy this May. Concerns on hiring of county attorney, name calling by Board Chair and Zoom availability.

Rory Mattson, Escanaba, addressed the Board with his concerns regarding history of the Park Board/Authority - they had dissolved themselves as the Conservation District was taking care of the parks. The Road Commission originally was in charge of the parks as they were roadside parks.

#### XIII. COMMISSIONERS CONCERNS

Commissioner Malnar: Septic tanks will be on a 5 year inspection schedule. He is on the MAC Transportation Board. \$3.9 billion funding deficit for roads. Looking at an increase of \$0.73/gallon in the gas tax, or increasing the registration fees, or implementing road usage fees.

Commissioner Viau: Will do his best to bring your concerns into his decisions. Wasn't coming to the defense of someone's right to speak, was doing the right thing. Citizens' Initiative - Ax Michigan Tax. Road funding problems - less gas tax. Airport Board - compliance - experience. Pinecrest Board Appreciation for Volunteers.

Commissioner Barron: "Whereas the ability of local jurisdictions to determine for themselves which projects should and should not be in their local communities, what plans are best and reasonable for each neighborhood rather than these decisions being forced upon the townships and municipalities without their best interest at hand." "No change of circumstance can change defect of character." Waldo Emerson. "Thinking is the hardest work there is, which is probably why so few engage in it."
