

A Regular Meeting of the Board of the Delta County Road Commissioners was held on Thursday, June 27, 2024 at 3:30 p.m. at the Main Office, 3000 32nd Avenue North, Escanaba, Michigan. Chairman Aschbacher called the meeting to order at 3:30 p.m., followed by the Pledge of Allegiance.

Chairman Aschbacher moved to approve the agenda with the following changes: Move Manager Contract from 5A to 10F & add roofing bid to 5A.

Chairman Aschbacher moved to approve the minutes for the June 10, 2024 Regular Meeting as proposed.

Manager Jody Norman gave a brief Admin Update: Jody discussed recent legislative updates with the commissioners. He also gave an update on where the crew is at on the MDOT & county systems. On the county system the crew is AMZ-ing and prepping gravels, chip sealing will start on July 8th. At the Haulquist facility, power vents need to be installed. Rumble strips were installed at the CR 525 / CR 414 intersection. Jody also informed the Commissioners about the tanker accident that took place on State Hwy M35.
