An inspection before and after the event will be performed to protect both interests of the LESSEE and the County of Delta/Delta County Parks and Campgrounds.

Cancellations: The user fee is NON-REFUNDABLE if LESSEE cancels or withdraws from this Lease Agreement for any reason from the Lessor's signature date.

No rights, claims, or payments accrue to the LESSEE should County of Delta/Delta County Parks and Campgrounds fail in performance of this Lease Agreement. County of Delta/Delta County Parks and Campgrounds may withdraw and/or cancel this Lease Agreement for any reason, including during the period of use of the Lease Agreement. Charges shall accrue to LESSEE for County of Delta/Delta County Parks and Campgrounds employee overtime resulting from the LESSEE or LESSEE's invitees' failure to vacate facility at closing time and/or the time ending this Lease Agreement. If any of these charges are more than the security deposit, the deposit will be forfeited to cover the costs.

Additional Requirements: LESSEE must initial below, acknowledging agreement to all additional requirements.

LESSEE and LESSEE's invitees adherence to the Park Rules of the County of Delta/Delta County Parks and Campgrounds and all applicable local, state, and federal laws shall be a requirement of this Lease Page 2 of 3

LESSEE and all invites using the facility by way of this Lease Agreement assume all risk, danger and incidentals to the use of this facility during the term of this Lease Agreement. LESSEE hereby guarantees and assumes full and exclusive responsibility for damage to property, fixtures, and equipment belonging to or used by County of Delta/Delta County Parks and Campgrounds, if cause by LESSEE or LESSEE's invitees during the period of this Lease Agreement. Costs for repair of damages, if less than the security deposit, shall be recoupable from the security deposit. LESSEE guarantees and assumes full and exclusive responsibility for the safety of the people and property of all participants, invitees of the LESSEE, spectators and public at any of the events contemplated by the LESSEE or put on by the LESSEE. LESSEE assumes all risks of the events; County of Delta/Delta County Parks and Campgrounds assumes none thereof.

LESSEE agrees to have responsible individuals on the premises for the duration of the event to insure orderly behavior and general conduct of LESSEE and LESSEE's invitees.
