- f. EGLE Renewable Ready Communities Award update Application for the funding is in process. - b. It was agreed that the Township Septic Tanks will be pumped and serviced at the Town Hall and the ballfield, and the cemetery outhouse pumped out for a total of \$850. Motion to accept as presented by Karen, 2nd by Terre. All in favor to accept as presented motion carried.
- c. Solar Taxation Exemption Legal representation for the process has been obtained by the Township and the preparation of the necessary materials for a public hearing is in process.
- d. Donations were received by the Township from the Perkins Lions Club, the Legion, and Auxiliary for the purchase an Adaptive Swing for the playground area.
